President's Message

Dear KWAA members:

Thank you for the privilege of serving as your President this year. It is a great honor to lead the Kansas Women Attorneys Association in the year of our 25th anniversary.

25 Years of Hard Work and Progress, Much Remains to Be Done

We have gone a long way. The issues used to be that women had to fight for the right to be accepted into law schools, for the right to work as lawyers, not support staff, after obtaining a Juris Doctor Degree. We are way past those times when all nine judges on the U.S. Supreme Court were men. Behind us are times when male judges used to call women lawyers "honey" in front of juries, or refuse to hear a woman lawyer's argument if she wore pants to court. These days, while we have much to celebrate, there are new issues to tackle. Women constitute less than 20% of equity partners at law firms. Women lawyers across the board are paid less than their male colleagues. Women are still a visible minority on the bench and in the legislature. And our pipeline, the law schools, are reporting that the number of women law students has dipped from 60% to around 40% in the past several years. So we still have our work cut out for us.

KWAA Past Presidents Council

This year, we asked our past presidents to form a KWAA Past Presidents Council, and they said YES! The Council is headed by Cathy Reeder. Linda Parks hosted the first meeting of the Council at her firm's Wichita office. The Council is an invaluable resource of institutional knowledge, wisdom and connections available to KWAA through generosity and hard work of our Past Presidents. They are the leaders who have put 25 years into making great progress on women issues, helped to build KWAA into a thriving organization with a strong distinct voice, and continue to give and stay involved.

New Resiliency Group Meeting in Lawrence

A confidential discussion group solely for lawyers convened in Lawrence in February, 2014. The Kansas Lawyers Assistance Program facilitates the group which meets at the Sloan, Eisenbarth Law Firm, 900 Mass, Ste. 400, on the first Friday of each month from noon to 1:00 p.m. Group members are welcome to bring their lunch. Dr. Rae Sedgwick, who holds both a J.D. and a Ph.D. in Psychol-

ogy, guides the group. The Resiliency Group, and any group sponsored by KALAP, is confidential and there is no charge for participation.

Resiliency is that skill which helps a person bounce back from difficult or stressful situations or events. Statistics indicate that lawyers experience depression or alcoholism at about double the rate for the general population so the development of resiliency traits is particularly beneficial to the profession. The groups are open to any Kansas lawyer or law student; one need not be working with KALAP to participate.

Dr. Sedgwick has been coordinating similar groups in Johnson County and Topeka for the past few years. The Overland Park Resiliency Group meets at the GSF law office, 10990 Quivira, in Overland Park from 5 to 6 every first and third Wednesday. The Topeka Group meets on the third Friday at noon at the KALAP Office, 515 S. Kansas Ave., Ste. 202.
